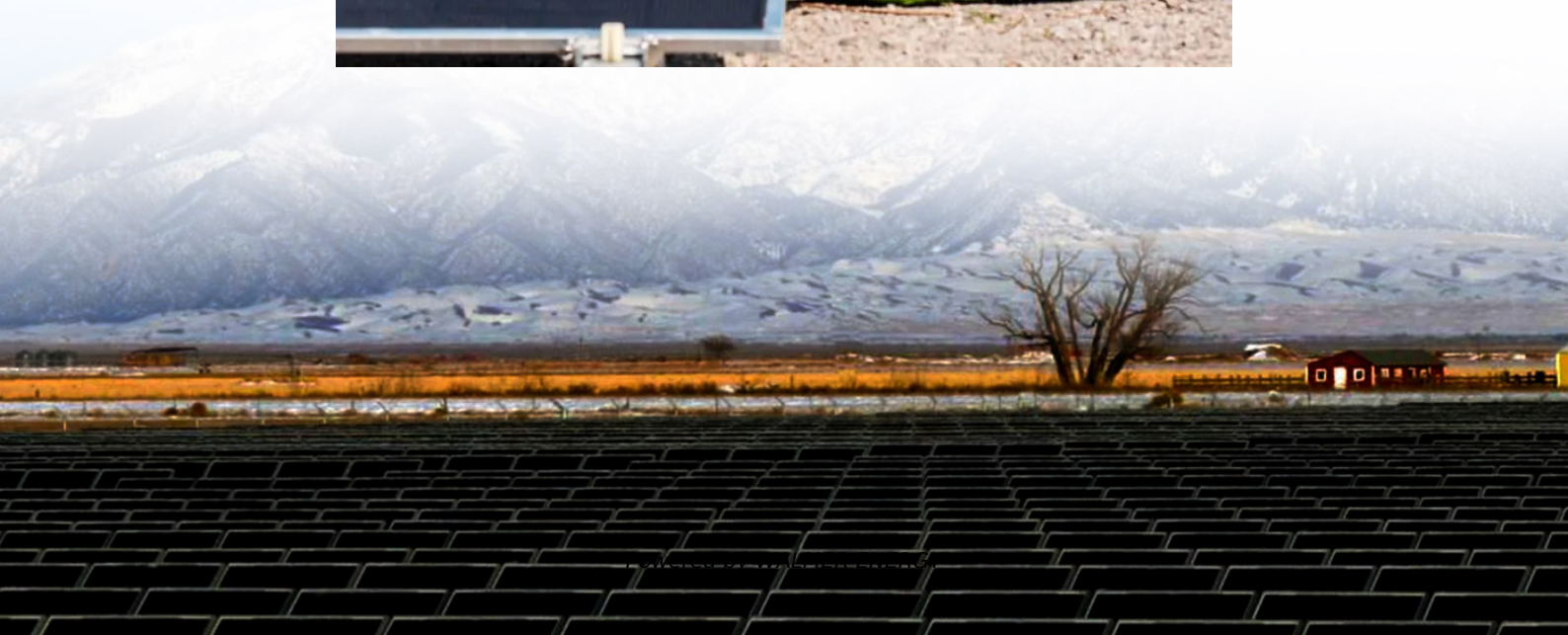

Which products are subject to customs duty in Qatar?

Pork, pork products, tobacco products, and alcoholic beverages are subject to a 100 % import duty. Projects funded by the Qatar Industrial Development Bank (QIDB) can be granted a customs duty waiver for the import of machinery, raw materials, and other industrial inputs.

Qatar's customs framework is structured to facilitate efficient trade through well-defined processes and duty tariffs. Central to this system is Al Nadeeb, an advanced digital platform that simplifies import and export procedures, ensuring seamless operations for businesses.

What is Qatar electronic customs clearance single window (Al nadeeb)?

The Qatar Electronic Customs Clearance Single Window (Al Nadeeb) is a one-stop e-government system to facilitate international trade. Regulations were introduced in 2013 to prevent fake products from entering the market. All general goods must have non-removable marking of their place of manufacture to be eligible for customs clearance.

Does Qatar have a tariff on steel?

Qatar also has a 20 % tariff on iron bars and rods, non-alloy hot-rolled steel and 12-millimeter steel bars as well as cement. Customs duties of 30 % are levied on imports of urea and 15 %% on imports of records and musical instruments.
