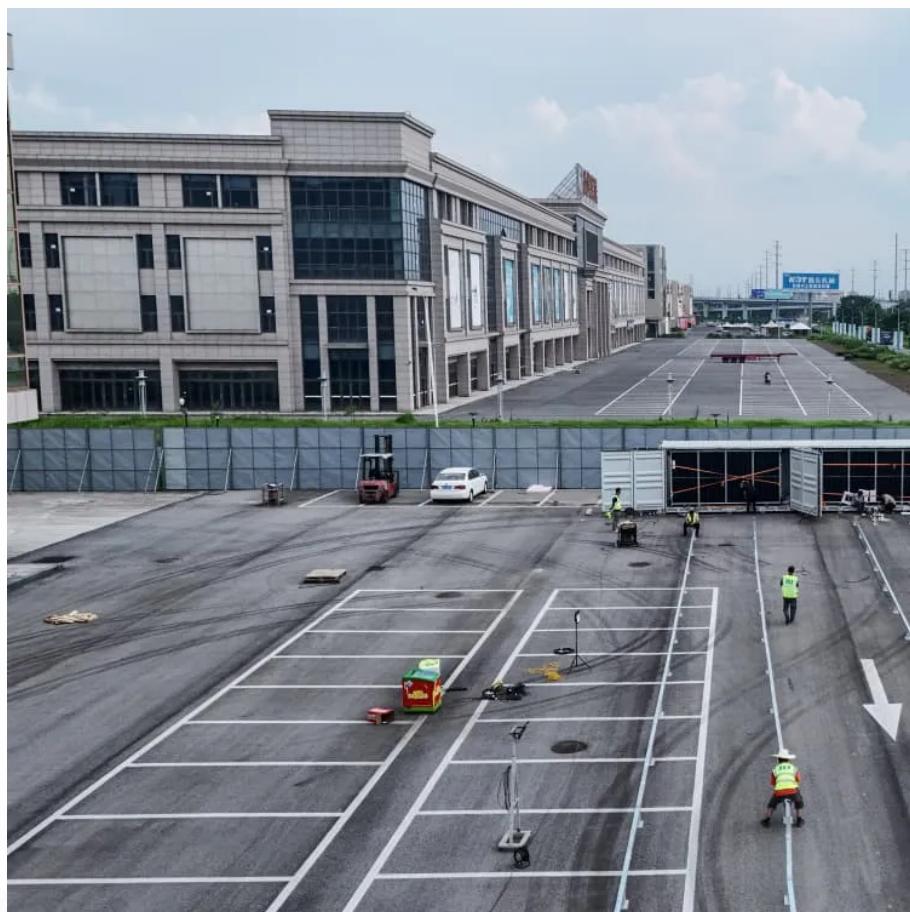

Overview

What is the Georgetown solar project?

The Georgetown Solar Project is a 278 MWdc solar photovoltaic project located in Vulcan County, Alberta, Canada. The project has completed all field work, obtained Power Plant and Permit & License approvals by the AUC for the construction, operation, and interconnection of the project to the Alberta Interconnected Electric System.

How many homes will the Georgetown solar project power?

Once operational, the Georgetown Project is expected to generate enough electricity to power approximately 42,550 homes. The Georgetown Solar Project is a 278 MWp solar photovoltaic project located in Vulcan County, Alberta, Canada.

How much money did the Georgetown project make in 2023?

The sale of the Georgetown Project closed in December 2023, bringing in over \$40 million. Sunnynook Solar (270 MWac / 332 MWdc): Located in Special Area No. 2, Alberta, the project has received approvals from the Alberta Utilities Commission (AUC) and secured grid interconnection in August 2024.

Where is Georgetown solar located?

Georgetown Solar Inc. is developing a 230-megawatt (MWac) solar project located 11 kilometres south of Carseland, Alberta in Vulcan County. The Project encompasses 700 acres (400 soccer fields) and has been sited on privately owned cultivated farmland.
