Overview

How many solar panels were imported into the US in 2024?

In 2024, the total finished US solar panel imports into the US amounted to 54.3 GW (gigawatt). Tariffs on solar panel imports from various Southeast Asian countries were implemented by the US Commerce Department, which could affect future import volumes.

Why are many countries importing solar panels?

Many countries are now importing solar panels to meet their energy needs. Imports of solar panels increased dramatically worldwide in 2024, as the market reached all-time highs. With around 593 GW of solar power generation installed globally in 2024, global imports of solar panels reached a significant value.

What are solar panel import tariffs?

Solar panel import tariffs are primarily intended to support the development of a new U.S.-based solar module manufacturing supply chain, which is financially backed by the Inflation Reduction Act. This act introduces a series of tax credits designed to bolster domestic manufacturers. For solar modules, the credits are as follows:.
