Overview

Does China impose a dumping duty on solar glass?

Measures in force In May 2014, the Commission imposed a definitive anti-dumping duty on imports of solar glass originating in the People's Republic of China ('the PRC' or 'China'), by Commission Implementing Regulation (EU) No 470/2014 (2) ('the original measures').

Is there an anti-dumping duty on solar glass?

OJ L 176, 30.6.2016, p. 21). Commission Implementing Regulation (EU) No 470/2014 of 13 May 2014 imposing a definitive anti-dumping duty and collecting definitively the provisional duty imposed on imports of solar glass originating in the People's Republic of China (OJ L 142, 14.5.2014, p. 1).

Which solar glass is subject to countervailing duty?

The solar glass subject to countervailing duty includes all glass fulfilling the abovementioned technical and physical characteristics, whether it is used for photovoltaic modules, flat photothermal energy collectors, furniture, to build greenhouses, or for other uses'.

Are anti-dumping measures necessary on imports of solar glass originating in the PRC?

Based on the information available concerning the Union interest, the Commission concluded that there are no compelling reasons against the maintenance of the definitive anti-dumping measures on imports of solar glass originating in the PRC.
