Overview

What is the export value of PV cells & modules?

According to the statistical data,¹ the export value of global PV cells and modules increased from approximately 54.7 billion USD to approximately 74.1 billion USD from 2012-2021, a growth of 35.5%, which was greater than that of global merchandise trade during the same period (20.3%).

Are trade barriers affecting Chinese exports of PV cells and modules?

According to the results in the first two columns in Table 2, compared with the trade situation between China and economies that have not initiated ACPs, the trade barriers between China and Europe and the USA has had a significant negative impact on Chinese exports of PV cells and modules.
