A solar PV export tariff is the payment you receive for excess solar power sent to the grid. What is the SEG and what tariffs are companies offering now?

How much do solar panels cost to export?

Find out which energy companies have the best rates. The amount you can get paid for exporting energy from your solar panels varies from a paltry 1p to 25p per kWh. That means that if you've got solar panels, choosing the best export tariff could earn you hundreds of pounds extra in payments every year.

Do you qualify for a low solar tariff?

Some energy companies have introduced temporarily high tariffs designed to persuade customers to go solar with them. To qualify, you have to get your solar panels and battery through the supplier – but once the initial 12-month export contract ends, you'll be rolled onto a lower tariff.

Can solar energy be exported back into the National Grid?

But that excess energy can be used elsewhere, by exporting it back into the National Grid, which then distributes it to wherever it is needed. The good news for solar panel owners is that large energy companies are obliged to pay for the excess energy that is exported under the Smart Export Guarantee (SEG) scheme.
