New regulations focus on four key areas: streamlining the industry by phasing out outdated capacity, ending price wars and below-cost dumping, improving product quality and cracking down on IP infringement, and promoting industry self-regulation. Do building regulations apply to solar panels?

Solar RECs (SRECs) are created for each megawatt-hour of electricity generated from solar energy systems. The ultimate owner of the SREC owns the "solar-ness" of the power.

Who owns solar power?

The ultimate owner of the SREC owns the "solar-ness" of the power. Many states create SREC markets to spur the development of solar by requiring electricity suppliers to purchase SRECs produced by in-state solar systems as part of their obligation under the state's Renewable Portfolio Standard (RPS).
